

Note: This is part of a larger narrative shift already underway through a statewide prevention architecture. We will continue to develop and implement the narrative shift through the Task Force recommendations, and with community and agency partners who have proximity to the work—especially those with lived expertise.

- The priorities seem **broad** how are we going to do it? How are we going to use data? Need some **specifics** on how it's going to get done
- There were several comments about the need to ensure the availability of a community pathway
- Explicitly call out legal resources such as pre-petition, in community pathways
- Don't think these priorities overall speak to how child welfare is represented not having access to legal equity. Parents only have access to legal counsel once all is lost.
- Priorities should speak more to the **equity** about giving families the same powers that these systems carry
  - Give families them the benefit of the doubt
  - Address gatekeeping of resources such as legal counsel
- It's not about fixing the mandated reporting system it's about how the system started and how it's harmful
- Sustainability of the resources to support these priorities is missing

## Pending recommendation



Although we recognize this recommendation may fall within the child welfare agency, we will need to seek further clarification, and therefore not directly in the purview of this Task Force, we are raising this as a crucial issue to address due to the detrimental impact on families and communities:

Examine child welfare policies and practices in which the names of individuals reported to a hotline are maintained in a database when the agency determines an investigation is not warranted or the allegations were unfounded. Assess whether the possible benefits to child safety are outweighed by the significant harm to families for a time with no limit or end date and the impact on increased bias and disproportionality.



Pilot a set of tools, practices and/or conditions that, when used in good faith, fulfill the legal requirements for mandated reporters; and thereafter, establish a group, which shall include youth and parents with lived experience, to review the impact of the pilot program through qualitative and quantitative data and to determine whether to move forward with complete elimination of liability for mandated reporters.

#### **Legal/Liability Issues for Mandated Reporters Subcommittee**

### **Process to Reach Consensus**

- Reviewed context document summarized the data and other information presented and reviewed by the subcommittee and discussed additional data on CA rates of unsubstantiated reports of physical and sexual abuse
- Originally three proposals 1) eliminating civil and criminal liability, 2) having a tool which fulfilled legal requirements and 3) having a pilot program with a plan determine whether to eliminate liability. Agreed to merge 2 and 3 as the pilot program envisions next steps
- Voted in our meeting and then via email for people who could not attend. Took votes for first proposal and then for second proposal
- Used gradients of agreement 1-5

#### Voting (15 committee members):

- Pilot proposal: 3 to 5 14 and 1 to 2 -- 1
- Eliminating proposal: 3 to 5 10 and 1 to 2 5
- For each proposal those who had voted 1 and 2 and were at the meeting talked about their vote.
- Based on the total number of 3-5 votes the pilot program proposal is being submitted
- Among the views expressed for the 1 and 2 votes on the proposal to eliminate liability the belief that liability was necessary to ensure reports for children who experience physical and sexual abuse; the belief that liability is needed to protect some children who need to be removed from their families; it is too risky to remove liability without proof that it would not cause harm; people will still report because they want to get kids services

#### **Legal/Liability Issues for Mandated Reporters Subcommittee**

#### Subcommittee Views of Pros and Cons of Recommendation



#### Pros:

- Iterative process to allow for testing of eliminating liability before enacting full elimination.
- Still keeps in the possibility of eliminating liability completely
- Allows for a slower roll out and testing and data before complete overhaul
- Liability is tied to a specific process rather generally which will help with overreporting while still mandating some reports and having consequences for failure to report
- More realistic and likely to get support from others and the Legislature
- In line with the New Hampshire which some support as a model
- Gives a specific tool, and essentially a receipt, and a way to see what alternative pathways were followed if recommended instead of a report

#### Cons:

- We already have qualitative and quantitative data, reports and recommendations showing not only that mandated reporting has not made children safer but actually has caused harm. Why are we willing to keep a harmful situation while we wait for proof that change would make a difference?
- Maintains the mindset that this criminal law for mandated reporting is necessary and effective for children to get help or achieve safety, including through child welfare authorities
- Maintains a system based on a fear-based focus on avoidance of liability rather than the needs of the individual child
- Does not address the oversized influence of insurance companies and other actors on over-reporting as effectively as eliminating liability

#### **Legal/Liability Issues for Mandated Reporters Subcommittee**

The Subcommittee had two other priority areas. We were not able to research and discuss these with the depth and time for the first recommendation. These priority areas had been voted on in the past and comments were made at that time.

These recommendations as worded were presented to the Subcommittee with the agreement that we would vote using the gradient process via email. There was some discussion at that time which led to editing of the wording.

We received 11 votes out of 15 committee members.

We have not been able to discuss the votes.



### Additional Recommendations



Review and assess changes to and clarification of the legal standards for reporting to clearly identify relevant thresholds. Current understanding of the standards "reasonable suspicion" and "substantial risk" are insufficient to guard against the harms of over-reporting and bias. Potential changes should include more detailed definitions or guidelines to provide clarity as well as a framework for how a mandated reporter might determine if the threshold is met.

• 3 to 5: 11

• 1 to 2: 0

Review and assess whether the individuals and professions listed as mandated reporters in California should be reduced in order to further the paradigm shift from mandated reporting to community supporting. In addition, this process should consider whether to establish criteria that must be met before any new individuals or professions are added to the list.

## **Emerging Recommendation 1**



Amend the Penal Code to remove general neglect as a requirement for mandated reporting AND amend the definition of severe neglect to mirror the definition of Severe Neglect used in the <u>California Structured Decision Making</u>.

#### **Narrowing the Legal Definition of Neglect Subcommittee**

## **SDM Severe Neglect Definition**



<u>Diagnosed malnutrition (automatic 24-hour).</u> The child has a current diagnosis by a qualified medical professional of severe malnutrition due to inadequate or unbalanced diet, OR a qualified medical professional states that there are indicators of malnutrition but a formal diagnosis has not yet been made.

Non-organic failure to thrive. The child has a current diagnosis by a qualified medical professional of non-organic failure to thrive, OR a qualified medical professional states that there are indicators of failure to thrive but a formal diagnosis has not yet been made.

<u>Child's health/safety is endangered.</u> The caregiver has willfully not provided adequate clothing, shelter, supervision, care, or medical care AND there is imminent danger of serious illness or injury; or serious illness, serious injury, or death has already occurred. Consider child's age, behavior, and vulnerability. For example:

- The child's clothing is so inappropriate for weather that the child suffered hypothermia or frostbite;
- Housing conditions result in lead poisoning, severely exacerbated asthma due to smoke exposure, and/or multiple bites from pest infestations;
- There is methamphetamine production in the home/residence:
- Medical care has not been provided for an acute or chronic condition and, as a result, the child has required or is likely to require hospitalization or surgery; or the
  condition may worsen to the extent that unnecessary permanent disability, disfigurement, or death results;
- Caregiver is willfully not meeting child's mental health needs and child has demonstrated suicidal or homicidal behavior/ideation;
- Child is not supervised to the extent that the child has been seriously injured, is at risk of being seriously injured, or avoided serious injury only due to intervention by a third party:
- A voung child is left in a motor vehicle during extreme temperature conditions:
- A caregiver behaves recklessly in proximity to child (e.g., driving under the influence with a child in the car, using weapons, etc.); or
- Caregiver is breastfeeding while using dangerous substances (type of substances and/or amount resulted in or is likely to result in serious injury/illness to child).

<u>Death of a child due to neglect (automatic 24-hour).</u> There has been a death of a child in the home due to neglect or circumstances that are suspicious for neglect. Select one of the following options.

- Death of only child or all children in home; no other children reported to be in the home.
- Other children reported to be in the home.

# Agreed Upon Recommendation: Identify essential learning content to disrupt racial bias in mandated reporter decisions and ensure all training includes this essential content.



#### Essential Content to include

- Bias (implicit and explicit), https://youtu.be/YrHIQIO bdQ?feature=shared
- Inclusive Language
- Trauma informed lens and strategies
- Review of Systematic Racism (see below video as an example)
- CA Law Include CANRA definition of child abuse
  - O The Child Abuse Prevention and Treatment Act (PC 11164-1174.3):
    - Requires that employers of Mandated Reporters (as identified in the Act) promote identification and reporting of child abuse or neglect
  - O Abuse and/or Neglect is defined as:
    - Any recent act or failure to act on the part of caretaker which results in death, serious physical or emotional harm, sexual abuse or exploitation, or an act or failure to act which presents an imminent risk of death or serious physical harm
- Review of Abuse Types (physical, sexual, emotional and neglect
- AB 2085- neglect defined
- CA Data- include data specific to disproportionality of African American and Tribal
- Legal/Liability
- Decision Making Tree
- Community resources (what are they and how to establish/ engage)
- Special Population Considerations: SUD, Mental Health, Domestic Violence, Teen Parents, Indigenous
- Cultural humility- lifelong learning; impact of all culture
- Training should be personable—include pictures/narratives that are representative of impacted group

#### Implementation Strategies



- Defined requirements/deadline for agencies to train all mandated reporters.
- All mandated reporter categories, and all levels are obligated to participate in training.
- Mandatory annual training for all mandatory reporters. Provide CEU's for training.
- Training needs to be hybrid (a portion completed in person and a portion can be completed independently.
- Length of training- needs to be longer than 2hours (4 hours min).
- Train the trainer: Anyone that is providing mandated reporter training needs to be certified.
  - O Gold standard training: any changes to training needs to go through an approval processo verseeing board for approval process; ongoing support after training- supporting agencies with implementation
    - overseeing board to support with annual updates
    - consider implementing/ creating an additional training that is a "refresher" for already trained staff
  - Gold standard training to include the above-mentioned content
- Community supports need to include workshops to educate caregivers/ community members on Child Welfare policies and practices. Free legal support for families who encounter DCFS.
- Communication/ policy updates with licensing boards to ensure they are aligned with CA shift to mandated supporter/ this will reduce fear of losing licensure.


